

COLUMBIA EMPIRE VOLLEYBALL FEES AND SANCTIONS

FEES FOR CLUB SEASON:

Try Out Fees – Per Day: \$5 *(Applied to Individual Registration if the player is picked up. Covers Insurance for player.)*

Memberships:

Junior Membership: \$55 *(Junior girls and junior boys playing with girls)*
Adult Membership: \$50 *(Coaches, Club Directors)*
Limited Adult Membership: \$35 *(Membership for Chaperones at National Tournaments)*

Club Fees:

Team Fee's: \$45 *(assigned to each team)*
Fingerprinting Fee: \$70 *(only processed and needed once)*
SSCI – (USAV): \$17.50 *(Background screening -every two years)*

Tournament Fees:

Friendship Tournaments: \$85-\$115 *(entry fee set by hosting club)*
Sanctioned Tournaments: \$150 *(fee to host a tournament)*

Power League:

Power League: \$500 *(per team for four tournaments total, Late Fee for PL Teams: After 10th-\$50, After 17th-\$100)*
Gold & Silver Division: \$105 *(per team for 18's Gold & Silver and 16's/14/12 Gold for R1 in all matches)*

Regionals:

2 Day Regionals: \$275 *(per team, top 16 seeded teams for 18, 16, 14)*
One Day Regionals: \$150 *(per team)*

Clinics

Impact Clinics \$25 *(Per coach, no renewal needed)*
Referee/Scorekeeper Clinic \$5 *(per attendee, Coaches and players attend 1st & 2nd year)*

Sanctions and reinstatement fees

Recruiting Violations	<p>1st Offense – Self Reported – One Month Suspension</p> <p>2nd Offense – Self Reported – Two Month Suspension</p> <p>1st Offense – Non-Self Reported – Two Month Suspension</p> <p>2nd Offense – Non-Self Reported – Remainder of Season</p> <p>Violation while on Probation – To Be Determined</p>
Transfer Rule	<p>Transfer prior to Jan. 1st - 2 month waiting period</p> <p>Transfer after Jan 1st - must wait till after Regional's (Unless the releasing Coach waives the waiting period)</p>
Power League Refund:	<p>Two Weeks Prior to Qualifier – Full Refund</p> <p>Less than two weeks - \$100 penalty - Remainder is refunded</p> <p>After Qualifier - \$100 penalty + prorated costs for tournament and remainder is refunded</p>
No Show	<p>No prior Notice - \$100 reinstatement fee – Drop one division</p> <p>Less than 1 Week - \$50 reinstatement fee - Drop one division</p> <p>More than 1 Week – Drop a Division</p>
Forfeits	Any match(s) in a Friendship or Power League is a \$50 fine
Officiating	<p>Failure to perform duties as required - \$50 fine</p> <p>1st Offense – No Certified Ref/SK - \$50 for the day for each.</p> <p>2nd Offense – No Certified Ref/SK - \$75 for the day for each.</p>
Uniform Violation:	Warning & correct
Yellow Cards	<p>First nothing, Second Warning Letter</p> <p>Third – 30 Days Suspension (Depending on Circumstances)</p>
